Clinical work and basic investigations could not able to be started immediately on the previously collected patients due to the covid 19 pandemic situation in the country and in the Hospital. When we started doing basic investigations from 10/11/2021 on already recruited patients about 150 patient not attended the clinic due to the Covid 19 situation and various other reasons. In order to collect the missing 150 patients we started the recruitment again from 10/11/2021. Up to now basic investigations of 302 patients were completed and waiting to recurred another 18 patients.
